GRANT OF OPTIONS ISSUED PURSUANT TO EMPLOYEE SHARE OPTION PLAN

RPMGlobal Holdings Limited (ASX: RUL) (the *Company*) hereby advises, that in accordance with Listing Rule 3.10, it has issued 943,000 options to key managers under the Company's long term incentive plan, the majority of which were issued to replace the options that expired and lapsed on 29 November 2018.
