Nitro Acquisition – Final Release of Shares from Voluntary Escrow

Further to the announcement to the market on 1 July 2021, RPMGlobal Holdings Limited (ASX: RUL) [RPM ®], confirms in accordance with listing rule 3.10A, that the second and final tranche of 47,971 ordinary RUL shares, issued on 1 July 2021 and held in voluntary escrow, will be released from voluntary escrow on 1 July 2023.

As previously announced, these shares form a part of a total of 95,941 shares issued by RPM to the prior owners of Environmental Social and Governance (**ESG**) services company Nitro Solutions Pty Ltd (**Nitro**), as part of the total consideration paid by RPM for the acquisition of 100% of the issued share capital of Nitro under the acquisition transaction that closed on 1 July 2021.
