CHAIRMAN'S REPORT

Dear Fellow Shareholders,

Financial Year 2023 ("FY23") was another year dominated by global events and economic challenges (the war in Ukraine, high inflation, rapid interest rate rises, supply chain disruptions, global banking instability etc.) which impacted our staff and customers in one way or another. However, through it all, the company was still able to grow revenue right across the business, including a 50% increase in software subscription license revenue.

During FY23, the company concluded \$70.5 million in new software license sales (herein referred to as Total Contracted Value "TCV") up \$14.2 million (25%) on FY22 TCV sales of \$56.3 million.

As a result of the growth in software TCV sales, at the end of FY23 the company had \$132.2 million in pre-contracted, software licence and maintenance revenue, to be recognised across future years.

With the transition from selling once-off perpetual licenses to subscription licenses complete, the company is now benefiting from the financial leverage that comes from transitioning to recurring revenue. Excluding COVID subsidies received in FY22, Earnings before interest depreciation and amortisation (EBITDA) grew \$8.5 million (243%) in FY23 to \$12.0 million (FY22: \$3.5 million).

Since early 2022, listed Australian technology sector companies have generally traded down, broadly in line with the global technology sector. This has been mostly driven by global inflation, together with a swift and significant increase in interest rates and the implied cost of equity capital. RPM was not immune to this trend. As at 30 June 2023, the company's share price had fallen by just over 10% to \$1.475 since 30 June 2022.

The RPM Board is of the view that the company's share price is currently undervalued and, accordingly, in May 2023 the Board resolved to extend the company's on-market share buyback for a further twelve months. During FY23, the company spent \$7.5 million

acquiring 4,787,993 of its shares on-market, at an average cost of \$1.56 per share.

The company began FY23 with 231,704,960 shares on issue and, as a result of options being exercised and shares being bought back on market, at the end of FY23 the company had 228,022,637 shares on issue.

On 11 July 2023, the company provided an update on software sales and expected EBITDA for FY23, which resulted in an increase in the company's share price to its current trading range of \$1.57 - \$1.65.

During FY23, the company paid the owners of Splashback \$0.8 million, for the Splashback environmental data software business acquired in November 2022, and paid the final \$0.2 million earn-out relating to the Revolution schedule optimisation software business acquired in July 2020.

Splashback specialises in capture, storage, and management of environmental data. Mining organisations have been asking for solutions that simultaneously manage environmental data while providing transparency and auditability for stakeholders and regulatory bodies. RPM's sustainability portfolio ticks those boxes and ensures that the right information is being captured and stored.

There have been no changes in the Board composition during the year. In FY2023 the Board formed a separate ESG and Sustainability (ESG&S) Committee which is chaired by one of our non-executive directors. The ESG&S Committee is tasked with assisting RPM to discharge its obligations and responsibilities with regards to ESG and sustainability matters and overseeing and implementing future disclosures that the company will need to make regarding Climate, ESG and Sustainability related matters into the future.

RPM continues to maintain a strong balance sheet with \$34.8 million of cash in the bank as at 30 June 2023 and no debt.

The Board has again resolved not to pay a dividend this financial year. The company has no franking credits and continuation of the

share buyback is currently considered the most appropriate form of capital management.

I would again like to acknowledge the effort and commitment of our staff, who once again grew both our Advisory and Software businesses.

The Board also thanks its shareholders for their ongoing support. We remain firmly of the opinion that the software investments made by the company will support and grow the business well into the future.

Market Commentary

Most western countries have formed a view that the world is moving from a system of free and fair access to commodities to one likely marked by inter-regional competition, unstable availability, and deglobalisation. This approach is expected to accelerate especially with respect to critical minerals. Most governments have released critical minerals policies aimed at diversifying their supply chain away from China and towards like-minded These countries. policies are driving government backed multigenerational investment into mining and the refining of critical minerals which RPM is supporting through several of its software solutions and service lines.

Electric Vehicle (EV) Original Equipment Manufacturers (OEMs) and Battery Cell Manufacturers are moving back to vertically integrated supply chains to gain greater control, ownership and certainty of supply. In many cases, EV OEMs are investing directly in miners, or entering into offtake agreements with miners, at a project level to secure access and guaranteed supply of the critical minerals necessary to manufacture EVs. These OEM's hold a view that ownership and/or control of the whole vertically integrated supply chain is needed to build EV's that are cost competitive against traditional internal combustion engine vehicles for the mass-market so as to meet the goals of the Paris Accord.

The entry into mining of these OEM's has also seen an increase in the adoption of the Responsible Mineral **Exploration** and Development (IRMA) Standard. Most suppliers within the OEM supply chain are required to work towards meeting IRMA requirements. The independent auditing aspect of this framework will continue to drive significant ESG service demand. RPM has established a long-term global framework agreement with the world's largest global motor vehicle OEM for Advisory services to support their efforts in this area.

Mergers and Acquisitions (M&A) roared back to life in 2023 with circa \$30 billion of mining deals announced over the past 12 months on the ASX alone. (Source: Refinitiv as at May 2023). This activity was initially focused on the Tier 1 miners (e.g. BHP's takeover of Oz Minerals, Newmont's takeover of Newcrest), but is now starting to once again become the preferred option in an inflationary, staff limited environment to de-risk producing or near production assets to increase reserves, rather than building new projects. There has also been a significant level of coal divestment as well as coal debt recycling activity during the year as traditional miners and financiers exit their coal positions to meet their greenhouse commitments. These activities are driving ongoing demand for our Australian advisory team (both technical and ESG).

ESG is everywhere. It is now the number one consideration on mining CEO's minds as they navigate their companies through climate change and transition to a lower carbon economy. Pretty much everything in mining now has an ESG component. Our entry into mining ESG was well timed. We now have the largest pure play ESG mining advisory business in Australia where we have continued to add ESG staff where available. The ESG division has been a positive addition to the advisory business both in terms of financial results and vitality. Our ability to provide a strong in-house ESG offering is setting us apart from our competitors as we cross sell both advisory and ESG services into many of our lenders and study mandates.

Most major producers in 2021 set Scope 1 and Scope 2 greenhouse gas targets. They are now well into mapping out and executing on their decarbonisation strategies. The pace of the roll out of these strategies has been accelerated by increasing regulatory requirements across many of the large mineral producing countries. Scope 3 is expected to increase in importance in the short to medium term as lenders to the industry are considering mandatory reporting of Scope 3 as part of their financing arrangements.

During FY23 commodity prices started to return to more historical levels and as such we expect commodity prices to be weaker in FY24 than they have been over the last few years with high volatility expected in battery and critical minerals. This softening of readily traded commodities like iron ore against an inflationary backdrop, has seen Tier 1 miners introduce different forms of travel, third-party services and recruitment bans to help manage their financial margins. Some have gone as far as completing a number of rounds of restructuring thereby releasing professional talent into the market which we have been able to employ. RPM's advisory work is not expected to be materially impacted by this approach as we tend to do less work for the Tier 1's as they typically have their own inhouse teams.

Recruitment was a challenge throughout most of FY23 but has started to open up again in the last part of the year across most of our key business verticals allowing us to start to fill long term roles with high calibre talent.

High Level Summary of Financial Results

In FY23 the company reported total revenue and other income of \$98.4 million an increase of 17% (\$14.3 million) over the previous year (\$84.1 million).

Advisory revenue lifted by 18% (\$4.7 million) to \$31.3 million (FY22: \$26.6 million) and software revenue increased by 18% (\$10.1 million) to \$66.1 million (FY2022: \$56.0 million).

In late June the company sold \$23.1 million in software subscription TCV bringing the full year value of software TCV to \$70.5 million a 25% (\$14.2 million) increase over the previous year (FY22: \$56.3 million).

As noted previously, it is important to understand that of the \$70.5 million in software TCV sold in FY23, \$62.7 million of it has not been recognised in the FY23 financial accounts as it will be reported as revenue over

future years, aligned with the committed contract terms with each customer.

At the start of FY24 (1st of July 2023) the company had \$132.2 million in pre-contracted, non-cancellable software revenue from multi-year software deals sold in previous years which will be recognised in future years, an increase of \$29.4 million (29%) over the same time last year (\$103.1 million).

The company starts FY24 with \$55.0 million in annually recurring software revenue (\$48.5 million as at 1 July 2022).

86% of the company's operating costs relate to employee costs which increased by \$2.6 million (4%) in FY23 compared with FY22. Until the last quarter of FY23 there has been a "war for talent" in both the mining and technology industries which has resulted in lifting employee salaries to compete for talent. The full financial impact of these increases will flow through into the FY24 financial accounts.

The company increased its investment in software development by 10%, spending \$18.2 million during the year (up \$1.7 million from the previous year). The increased investment was targeted at supporting the company's movement of software products to the cloud.

Earnings before Interest, Tax, Depreciation, and Amortisation (EBITDA) excluding COVID subsidies increased \$8.5 million year on year to \$12.0 million (FY22: \$3.5 million) and cash inflows from operations for the year were \$12.2 million.

Profit after Tax from continuing operations increased by \$8.3 million year on year to \$3.7 million (FY22: Loss after tax \$4.6 million).

Advisory

FY23 was another strong year for the advisory division as we fully integrated our new ESG and engineering teams into a single entity.

This division increased its capability and market share to become a leading advisor to financiers, off-takers and vehicle OEMs, supporting the development of battery and

critical minerals projects globally, including for a number of large government-backed projects.

The advisory division grew its lender engineering practice year on year, with significant growth in the Americas, Australia and Africa, where the combination of engineering and ESG capabilities provided a key competitive advantage.

The company continues to expand its ESG service lines with a focus on assisting our mining clients with their decarbonisation and mine closure plans.

Large mining studies in Europe, the Middle East and Asia provided a strong foundation for our mining and geology teams to open opportunities to cross sell the company's software products and advisory services into new markets.

The advisory division improved both its utilisation and realisation rates across all service lines due to improved integration of the team, higher activity in the Americas, and a greater percentage of higher margin engagements.

Software

For the fifth year in a row, in FY23 the company set a new record for software licenses sold.

AMT (the company's asset maintenance solution) is poised to become the mining industries de facto standard for mobile mining equipment maintenance for the Tier 1 and 2 miners and mining OEM's. FY24 will see the company continue to hire software consultants (project managers, implementation experts, etc.) to meet the growing demand for this product.

XECUTE (the company's ultra short-term planning solution) continues to make positive in-roads into the market as the product broadens its solution footprint to satisfy larger mining operations.

ShiftManager (the company's Shift Management solution) was successfully implemented into a number of key sites in FY23 which will provide important reference points for miners looking to improve their shift management practices.

During FY23 the company welcomed 37 customers who signed up to use the company's new products for the first time. While these customers have purchased software to address a specific need, our expectation is that over time they will purchase and roll out additional products from our integrated suite of solutions.

During the early part of FY23 all but one of our large development projects was completed. This allowed the development team the opportunity to improve the scalability, robustness and integration management of our products, whilst continuing our slow march of moving the heavy data processing logic, which sit inside our products, to the Azure environment enhancing the company's cloud push.

As the size of our software implementations grows there is a need to provide additional scalability to the Tier 1 miners who want to be able to run global operations in a single instance.

FY24 will see a return to new product development with two new software products being released to the market along with several module extensions.

Future Outlook

In each of the last five years the company has set new software sales records and we expect to do so again in FY24.

AMT, XECUTE and ShiftManager are all expected to perform strongly in the year ahead.

The impressive software sales finish to FY23 has laid a strong foundation for the software consulting team in FY24.

We expect to grow our ESG and engineering team globally based on the forward demand we are currently seeing for both ESG and

financiers work. Leading into FY24 the company has circa six months of precontracted advisory work, which includes an increasing percentage of long-term recurring advisory work.

With the heightened activity in the market and our strong positioning in the battery and critical minerals space supporting financiers, we expect another strong year from the Advisory team.

The operating leverage provided from the \$132.2 million in pre contracted software revenue will support EBITDA growth in FY24.

With a strong balance sheet, competitive advisory and software offerings, strong pipelines, and referenceable customers we are excited and optimistic about the year ahead.

Total Revenue from continuing operations in the 2023 financial year grew by 17% to \$98.4 million (2022: \$84.1 million) with that increase attributable to strong growth of advisory revenue (18%) and software revenue (18%).

¹ Underlying Earnings before Interest, Tax, Depreciation, Amortisation, Management Incentives and significant one-off costs is a non-IFRS disclosure. In the opinion of the Directors, the Group's EBITDA reflects the results generated from ongoing operating activities and is calculated in accordance with AICD/Finsia principles. The non-operating adjustments outlined above are considered to be non-cash and/or non-recurring in nature. These items are included in the Group's consolidated statutory result but excluded from the underlying result. EBITDA has not been audited or reviewed.

From a management viewpoint, RPM monitors software subscription revenue in terms of Total Contracted Value (TCV²) being the total revenue to be received over the committed term of each contract. Whilst only a portion of the TCV is recognised as revenue during the financial year in which the contract is signed, we incentivise our sales team on TCV contracted during the financial year. As such, we often refer to subscription sales during the year in terms of TCV, rather than the amount of subscription revenue that is recognised as revenue during that financial year.

Perpetual licence sales and subscription revenue recognised during the 2023 financial year was \$42.2 million compared to \$28.0 million in the previous year. However, more importantly, total contracted software revenue contracted in the 2023 financial year was \$70.5 million, compared to \$56.3 million in the prior financial year.

Other revenue in the financial year included \$0.7 million from a bad debt recovery from a Ukrainian customer that had previously been unable to pay RPM due to the impacts of the war with Russia (2022: other revenue included US Covid subsidies \$1.0 million).

EBITDA from continuing operations increased by \$7.5 million to \$12.0 million (2022: \$4.5 million).

The Group's profit after tax of \$3.7 million included \$1.0 million in redundancy costs following the restructure of the software sales team in the Americas.

During the year, the Group made payments of \$1.0 million to the owners of two businesses purchased over the last three years. The Company bought back \$7.6 million of its own shares (between 1 July 2022 and 30 June 2023).

As at 30 June the Group had cash reserves of \$34.8 million and no bank debt.

² Total Contracted Value is a non-IFRS disclosure. In the opinion of the Directors, the Group's TCV better reflects software sales generated from ongoing operating activities. TCV has not been audited or reviewed.

Software Division

Software revenue was up 18% on the previous year. Subscription revenue increased by \$13.1 million to \$39.3 million (2022: \$26.2 million) and perpetual licence sales increased by \$1.1 million to \$2.9 million (2022: \$1.8 million). Maintenance revenue reduced by \$2.7 million to \$13.7 million (2022: \$16.4 million) as more customers decided to transition their perpetual licences to subscription licences.

Annual Recurring Revenue (ARR¹) for subscription software licences and support (maintenance) revenue at year end was \$55.0 million (June 2022: \$48.5 million).

Software consulting revenue decreased by \$1.4 million to \$10.2 million (2022: \$11.6 million) as some implementation services were bundled into the software subscription for several customers.

The Group increased its investment in Research and Development by \$1.7 million lifting the total investment in software R&D to \$18.2 million (2022: \$16.5 million). The company expenses its research and development costs.

The Company concluded agreements during the financial year with 37 customers who purchased new software products from RPM for the first time.

Advisory Division

The Advisory division provides independent consulting and advisory services which cover technical and economic analysis and assessment of mining activities and resources on behalf of mining companies, financial institutions, government agencies and suppliers to mining projects. The market for Advisory services is heavily reliant on expansion, development, financing and transacting of mining assets and projects.

Revenue from Advisory services for the year increased by \$4.7 million (18%) to \$31.3 million (2022: \$26.6 million) due to growth in the Metals and ESG divisions.

5. Likely Future Developments - Business Strategies and Prospects for Future Financial Years

We expect our Advisory business to have another strong year in financial year 2024. The new ESG division is performing well and our utilisation of these skills in the wider Advisory business continues to improve as we work with our customers on projects.

With new software products to sell and an uplift in the performance of our largest and highest value products, we are excited about the year ahead. Further, the addition of software consulting capacity has enabled us to manage more software projects simultaneously.

The company has continued to invest significantly on the software products resulting in more complete and richer set of products than last year.

With the transition to subscription sales now complete, the operating leverage provided from the \$132.2 million in pre contracted software revenue provides a solid foundation for financial growth and profitability.

With a strong balance sheet, competitive advisory and software offerings, strong pipelines, and referenceable customers, we are excited and optimistic about the year ahead.

6. Key risks and risk management

The company has a detailed risk management framework, that assesses the key financial and non-financial risks that have the potential, should they occur, to result in significant consequences to the company. The framework is integrated into the daily management of the business to ensure the oversight and management of business risks. Further details of the risk management framework and processes are detailed in RPM's Corporate Governance Statement. Listed below are relevant key risks for the business identified in the risk management framework:

The company board and management understand the importance of maintaining a sound and practical system of risk oversight, management and the associated internal controls. RPM maintains an Enterprise Risk Management (ERM) Policy which is designed to protect its people, clients and assets including intellectual property and thereby enhancing the value delivered to shareholders. The RPM ERM policy assists to identify, mitigate and manage risks on an enterprise wide basis with the Board reviewing and updating key strategic risks impacting the company annually.

During FY2023 the Board reviewed and updated the key strategic risks managed pursuant to the ERM. The key risks faced by RPMGlobal Holdings Limited, and their associated controls have been established to manage those risks are set out in the following table:

This report discusses the Group's policies in regard to compensation of key management personnel (KMP). The identified KMP have authority and responsibility for planning, directing and controlling the activities of the Group.

In addition to the Directors, the Company assessed the Chief Financial Officer and Group General Counsel & Company Secretary as having authority and responsibility for planning, directing and controlling all activities of the Group, directly or indirectly.

The Board has established a HR and Remuneration Committee to assist with fair and responsible remuneration and incentive policies enabling the Group to attract and retain KMP and Directors who will create value for shareholders and support the Group's mission. The HR and Remuneration Committee obtains independent advice if required on the appropriateness of compensation packages given trends in comparative companies. In the 2023 financial year the Committee did not use a remuneration consultant. The Group's Corporate Governance Statement provides further information on the role of this Committee. The compensation structures explained below are designed to attract suitably qualified candidates, reward the achievement of strategic, operational objectives and achieve the broader outcome of creation of value for shareholders.

Executive Director and other Key Management Personnel

The compensation structures take into account:

- The capability and experience of the KMP;
- Their ability to control the relevant segment's performance;
- The segment or Group earnings; and
- The connection of remuneration policies to deliver an increase in the company's share price and therefore financial return to shareholders.

Compensation packages include a mix of fixed, short-term and long-term performance-based incentives. In addition to their salaries, the Group also provides non-cash benefits to its KMP and contributes to a defined contribution superannuation plan (or equivalent pension plan) on their behalf.

Fixed Compensation

Fixed compensation is calculated on a total cost basis and includes salary, allowances, non-cash benefits, employer contributions to superannuation funds and any fringe benefits tax charges related to employee benefits, including motor vehicles parking provided.

Compensation levels are reviewed using an individual approach, based on evaluation of the individual, and a comparison to the market. A KMP's compensation is also reviewed on promotion.

Performance Linked Compensation

Performance linked compensation includes both short-term and long-term incentives and is designed to reward each KMP for meeting and exceeding their Key Performance Objectives (KPOs). The Short-Term Incentive (STI) is an 'at risk' incentive provided in the form of cash, while the Long-Term Incentive (LTI) is provided as options over ordinary shares of the Company under the rules of the Employee Share Option Plan (ESOP) (see note 23 to the financial statements). The current long-term performance incentive structure was first implemented in the 2013 year and was most recently approved by shareholders at the 27 October 2022 Annual General Meeting.

Short-term Incentive

Effective 1 July 2012, the Group implemented a variable pay structure, referred to as the Executive Incentive Plan (EIP). Each of the identified KMP has a portion of their remuneration linked to the EIP. The key objective of the EIP is to create clear alignment between individual and business performance and remuneration by providing a performance-based reward to participants in line with their relative contribution to the Group. The EIP achieves the alignment by focusing participants on achieving goals which contribute to sustainable shareholder value and providing a clear link between performance and the Group financial result.

During the 2018 financial year the business began transitioning from selling once-off perpetual software licenses to offering subscription licenses. In 2020 as a reflection of the strategic importance of growing subscription revenue, the Board introduced a software sales Total Contracted Value (TCV) target as a part of the EIP.

21A. Principles Used to Determine the Nature and Amount of Remuneration (Continued)

Until January 2022, there was a clear correlation between the growth in TCV from software subscription sales and the increase in shareholder value through the positive movement in the company's share price. Because of this, the Board's logic when setting the full year 2023 management targets was if management could continue to grow the company's total revenue and software TCV (which delivers committed revenue to the company over future years), then there should be a corresponding increase in the company's share price and therefore financial return to shareholders as had been shown to occur in prior years.

While the Group's TCV and revenue growth in 2023 did not deliver a corresponding increase in the company's share price over the same period, as it had in the previous two financial years, the Board believes the company's intrinsic value has increased each year as a result of the growth in TCV and underlying earnings.

The 17% increase in total revenue and 25% increase in software subscription TCV growth year-on-year resulted in the EIP targets being achieved and therefore 100% of the EIP was awarded for the financial year.

Cash bonuses are paid, provided for or forfeited in the year to which they relate.

Long-term Incentive

Options were issued in the 2021, 2022 and 2023 financial years under the Company's Employee Share Option Plan (ESOP) to KMP's at the discretion of the Board. Consistent with the current ESOP terms last approved by shareholders at the Company's 2019 Annual General Meeting, the rules of the ESOP enable the Board to determine the applicable vesting criteria and to set a timetable for vesting of options in the Offer Document, including vesting in tranches over a defined period.

The Board has the discretion on whether or not to set performance hurdles for vesting or to link vesting solely to a defined service period in order to drive key staff retention and reward longevity of service.

The options issued from November 2020 have a zero exercise price and vest in one single tranche three years from the grant date, with vesting conditions linked to the holder maintaining employment with the Group over that period and Total Shareholder Return on the company's shares overperforming the ASX 300 accumulated index (AXKOA).

The Board has a Margin Loan policy that restricts Directors and Executives of the Group from entering into financial contracts secured by shares and other securities of the Company. This policy requires the approval of the Chairman of the Board for any financial arrangements or facilities related to Company shares held by the Directors and Executives.

1. Summary of Significant Accounting Policies

The principal accounting policies adopted in the preparation of the financial report are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

RPMGlobal Holdings Limited is a listed public company, incorporated and domiciled in Australia.

The financial report comprises the consolidated entity ("Group") consisting of RPMGlobal Holdings Limited and its subsidiaries.

The financial report was authorised for issue on 25 August 2023.

(a) Basis of Preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and interpretations issued by the Australian Accounting Standards Board and the *Corporations Act 2001 (Cth)*. RPMGlobal Holdings Limited is a for-profit entity for the purposes of preparing the financial statements.

Compliance with IFRS

The consolidated financial statements of RPMGlobal Holdings Limited also comply with International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB).

Historical cost convention

These financial statements have been prepared under the historical cost convention.

(b) Principles of Consolidation

The consolidated financial statements incorporate the assets and liabilities of all entities controlled by RPMGlobal Holdings Limited as at 30 June 2023 and the results of all controlled entities for the year then ended. RPMGlobal Holdings Limited and its controlled entities together are referred to in this financial report as the "consolidated entity" or the "Group".

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity.

Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for the acquisition of subsidiaries by the Group (refer to note 1(j)).

Intercompany transactions, balances and unrealised gains on transactions between Group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

1. Summary of Significant Accounting Policies (Continued)

(c) Income Tax

The income tax expense or revenue for the period is the tax payable on the current period's taxable income based on the national income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the reporting date and are expected to apply when the related deferred income tax asset is realised, or the deferred income tax liability is settled.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses in the tax jurisdiction in which they arose.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in controlled entities where the parent entity is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

Tax consolidation legislation

RPMGlobal Holdings Limited and its wholly owned Australian controlled entities have implemented the tax consolidation legislation.

The head entity, RPMGlobal Holdings Limited, and the controlled entities in the tax consolidated group account for their own current and deferred tax amounts. These tax amounts are measured as if each entity in the tax consolidated group continues to be a standalone taxpayer in its own right.

In addition to its own current and deferred tax amounts, RPMGlobal Holdings Limited also recognises the current tax liabilities or assets and the deferred tax assets arising from the unused tax losses and unused tax credits assumed from controlled entities in the tax consolidated group.

Assets or liabilities arising under tax funding agreements with the tax consolidated entities are recognised as amounts receivable or payable to other entities in the Group. Details about the tax funding agreements are disclosed in note 4.

Any difference between the amounts assumed and amounts receivable or payable under the tax funding agreement are recognised as a contribution to (or distribution from) wholly-owned tax consolidated entities.

1. Summary of Significant Accounting Policies (Continued)

(d) Segment Reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operational decision maker. The chief operating decision maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the CEO and Managing Director.

The assets and liabilities of the Group are regularly reviewed on a consolidated basis but are not regularly reported to the chief operating decision maker at a segment level. As such this information has not been included in the Operating Segment note 26.

(e) Foreign Currency Translation

i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The consolidated financial statements are presented in Australian dollars, which is RPMGlobal Holdings Limited's functional and presentation currency.

ii) Transactions and balances

Foreign currency transactions are initially translated into the functional currency using the exchange rates prevailing at the date of the transaction. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss, except when they are deferred in equity as qualifying cash flow hedges and qualifying net investment hedges or are attributable to part of the net investment in a foreign operation.

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss and translation differences on non-monetary assets such as equities whose changes in the fair value are presented in other comprehensive income are recognised in other comprehensive income.

iii) Group entities

The results and financial position of all the Group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities on consolidation are translated at the closing rate at the reporting date;
- income and expenses are translated at the exchange rates prevailing at the dates of the transaction; and
- all resulting exchange differences are recognised in other comprehensive income.

In disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in profit or loss.

Fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entities and translated at the closing rate.

1. Summary of Significant Accounting Policies (Continued)

(f) Revenue Recognition

i) Licence Sales

Revenue from the sale of perpetual licences is recognised at a point in time when the customer gains access and thus control of the software and where the licences are considered distinct from other services provided to the customer.

ii) Software subscription

Revenue from the sale of term (subscription) licences are recognised over time on a straight-line basis over the subscription term.

iii) Consulting

Revenue from the provision of consulting services is recognised typically over time using the input method as the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for its performance completed to date.

iv) Software maintenance

Revenue for software maintenance is recognised over time on a straight line basis over the service period as performance obligations require the Group to respond to requests made by customers to provide technical product support and unspecified updates, upgrades and enhancements on a when-available and if-available basis.

v) Laboratory testing revenue

Revenue from sample testing is recognised at a point in time when the laboratory completes testing, and the customer receives testing results for their samples.

vi) Customer contract with multiple performance obligations

The Group frequently enters into multiple contracts with the same customer and where that occurs the Group treats those arrangements as one contract if the contracts are entered into at or near the same time and are commercially interrelated. The Group does not consider contracts closed more than three months apart as a single contract.

The Group's subscription contracts are combining an obligation to receive a licence, software support services and other services obligations. The provision of services and sale of licences is treated as a single performance obligation and recognised over time on a straight-line basis over the subscription term.

In all other cases, the total transaction price for a customer contract is allocated amongst the distinct performance obligations based on their relative stand-alone selling prices. Where the stand-alone prices are highly variable the Group applies a residual approach.

vii) Incremental Costs of obtaining Customer Contracts

The Group recognises as an asset the incremental costs of obtaining a contract with a customer if the Group expects to recover those costs. The incremental costs of obtaining a contract are those costs that the Group incurs to obtain a contract with a customer that it would not have incurred if the contract had not been obtained, such as commissions or third party software costs.

Costs to obtain a contract that would have been incurred regardless of whether the contract was obtained are recognised as an expense when incurred, unless those costs are explicitly chargeable to the customer regardless of whether the contract is obtained.

1. Summary of Significant Accounting Policies (Continued)

(f) Revenue Recognition (Continued)

The Group recognises the incremental costs of obtaining a contract as an expense when incurred if the amortisation period of the asset that the Group otherwise would have recognised is one year or less.

viii) Trade Receivables and Contract Assets

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business. They are generally due for settlement within 30 days and therefore are all classified as current. Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value.

The Group holds the trade receivables with the objective to collect the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional.

ix) Contract liability

A contract liability is the obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer. If a customer pays consideration before the Group transfers goods or services to the customer, a contract liability is recognised when the payment is made, or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the Group performs under the contract.

x) Financing components

The Group does not recognise adjustments to transition prices or Contract balances where the period between the transfer of promised goods or services to the customer and payment by customer does not exceed one year.

xi) Interest income

Revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

(g) Investments and Other Financial Assets

Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through Other Comprehensive Income (OCI), or through profit or loss); and
- those to be measured at amortised cost.

The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows.

1. Summary of Significant Accounting Policies (Continued)

(g) Investments and Other Financial Assets (Continued)

For assets measured at fair value, gains and losses will either be recorded in profit or loss or OCI. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income (FVOCI).

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss (FVPL), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

- Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows
 represent solely payments of principal and interest are measured at amortised cost. Interest income from
 these financial assets is included in finance income using the effective interest rate method. Any gain or
 loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses),
 together with foreign exchange gains and losses. Impairment losses are presented as separate line item
 in the statement of profit or loss.
- FVOCI: Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest revenue and foreign exchange gains and losses which are recognised in profit or loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to profit or loss and recognised in other gains/(losses). Interest income from these financial assets is included in finance income using the effective interest rate method. Foreign exchange gains and losses are presented in other gains/(losses) and impairment expenses are presented as separate line item in the statement of profit or loss.
- FVPL: Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVPL. A gain or loss on a debt investment that is subsequently measured at FVPL is recognised in profit or loss and presented net within other gains/(losses) in the period in which it arises.

Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost and FVOCI. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by AASB 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

1. Summary of Significant Accounting Policies (Continued)

(h) Cash and Cash Equivalents

For statement of cashflows presentation purposes, cash and cash equivalents include cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily converted to known amounts of cash and which are subject to an insignificant risk of changes in value and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the consolidated statement of financial position.

(i) Leases

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the group.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable
- variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- amounts expected to be payable by the group under residual value guarantees
- the exercise price of a purchase option if the group is reasonably certain to exercise that option, and
- payments of penalties for terminating the lease, if the lease term reflects the group exercising that option.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases held by the Company, which does not have recent third party financing, and
- makes adjustments specific to the lease, e.g., term, country, currency and security.

The group is exposed to potential future increases in variable lease payments based on an index or rate, which are not included in the lease liability until they take effect. When adjustments to lease payments based on an index or rate take effect, the lease liability is reassessed and adjusted against the right-of-use asset. Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

1. Summary of Significant Accounting Policies (Continued)

(i) Leases (Continued)

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- any initial direct costs, and
- restoration costs.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the group is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life. While the group re-values its land and buildings that are presented within property, plant and equipment, it has chosen not to do so for the right-of-use buildings held by the group.

Payments associated with short-term leases of equipment and vehicles and all leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months or less without extension options. Low-value assets comprise IT equipment and small items of office furniture.

(j) Business Combinations

The acquisition method of accounting is used to account for all business combinations, including business combinations involving entities or businesses under common control, regardless of whether equity instruments or other assets are acquired. The consideration transferred for the acquisition of a subsidiary comprises the fair values of the assets transferred, the liabilities incurred, and the equity interests issued by the Group.

The consideration transferred also includes the fair value of any contingent consideration arrangement and the fair value of any pre-existing equity interest in the subsidiary.

Acquisition-related costs are expensed as incurred. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition date. On an acquisition-by-acquisition basis, the Group recognises any non-controlling interest in the acquiree either at fair value or at the non-controlling interest's proportionate share of the acquiree's net identifiable assets.

The excess of the consideration transferred, the amount of any non-controlling interest in the acquiree and the acquisition date fair value of any previous equity interest in the acquiree over the fair value of the Group's share of the net identifiable assets acquired is recorded as goodwill. If those amounts are less than the fair value of the net identifiable assets of the subsidiary acquired and the measurement of all amounts has been reviewed, the difference is recognised directly in profit or loss as a bargain purchase.

Where settlement of any part of cash consideration is deferred, the amounts payable in the future are discounted to their present value as at the date of exchange. The discount rate used is the entity's incremental borrowing rate, being the rate at which a similar borrowing could be obtained from an independent financier under comparable terms and conditions.

Contingent consideration is classified either as equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in profit or loss.

1. Summary of Significant Accounting Policies (Continued)

(k) Impairment of Non-Financial Assets

Goodwill and intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use.

For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

(I) Property, Plant and Equipment

Property, plant and equipment is stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment over its estimated useful life to the consolidated entity, or in the case of lease hold improvements, the shorter lease term. Estimates of remaining useful lives are made on a regular basis for all assets.

The estimated useful lives for plant and equipment ranges between 2 and 20 years. Gains and losses on disposals are determined by comparing proceeds with the carrying amount of the assets. These are included in profit or loss.

(m) Intangible Assets

i) Software developed or acquired for sales and licensing

Research expenditure is recognised as an expense as incurred. Costs incurred on development projects (relating to the design and testing of new areas of products) are recognised as intangible assets when it is probable that the project will, after considering its commercial and technical feasibility, be completed and generate future economic benefits and its costs can be measured reliably. The expenditure capitalised comprises all directly attributable costs, including costs of materials, services, direct labour and an appropriate proportion of overheads. Other development expenditures that do not meet these criteria are recognised as an expense as incurred. Development costs previously recognised as an expense are not recognised as an asset in a subsequent period. Capitalised development costs and acquired software are recorded as intangible assets and amortised from the point at which the asset is ready for use on a straight-line basis over its useful life, which varies from three to five years.

ii) Software – internal management systems

Software licences used in internal management systems, whether acquired or internally developed are stated at cost less amortisation. They are amortised on a straight-line basis over the useful life from 2.5 to 5 years.

iii) Patents and trademarks

Costs associated with patents and trademarks are expensed as incurred.

1. Summary of Significant Accounting Policies (Continued)

(m) Intangible Assets (Continued)

iv) Customer Contracts and Relationships

The net assets acquired as a result of a business combination may include intangible assets other than goodwill. Any such intangible assets are amortised in a straight line over their expected future lives. The estimated useful lives of customer contracts is 5 years.

v) Goodwill

Goodwill represents the excess of the cost of an acquisition over the fair value of the Group's share of the net identifiable assets of the acquired subsidiary/business at the date of acquisition. Goodwill on acquisition is included in intangible assets. Goodwill is not amortised. Instead, goodwill is tested for impairment annually or more frequently if events or circumstances indicate that it might be impaired and is carried at cost less accumulated impairment losses.

Goodwill is allocated to cash generating units for the purposes of impairment testing. The allocation is made to those cash generating units or groups of cash generating units that are expected to benefit from business combination in which goodwill arose, identified according to operating segments or components of operating assets (note 26).

(n) Trade and Other Payables

These amounts represent liabilities for goods and services provided to the Group prior to the end of the financial year and which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition.

(o) Borrowing Costs

Borrowing costs incurred for the construction of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Other borrowing costs are expensed.

(p) Employee Benefits

i) Short term obligations

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liability for annual leave and long service leave is recognised in the provision for employee benefits.

Other long-term employee benefit obligations

The liability for long service leave and other benefits which is not expected to be settled within 12 months after the end of the period in which the employees render the related service is recognised in the provision for employee benefits and measured as the present value of expected future payments to be made in respect of services provided by employees up to the end of the reporting period using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the end of the reporting period on commercial bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

1. Summary of Significant Accounting Policies (Continued)

(p) Employee Benefits (Continued)

The obligations are presented as current liabilities in the consolidated statement of financial position if the Group does not have an unconditional right to defer settlement for at least twelve months after the reporting period, regardless of when the actual settlement is expected to occur.

ii) Incentives

The Group recognises a liability and an expense for incentives based on a formula that takes into consideration the profit attributable to the Company's shareholders after certain adjustments. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation. Liabilities for incentive plans are expected to be settled within 12 months and are measured at the amounts expected to be paid when they are settled.

iii) Superannuation

The Group has a defined contribution superannuation plan for its eligible employees. Contributions to the defined contribution fund are recognised as an expense as they become payable. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in future payments is available.

iv) Share-based payments

Share-based compensation benefits are provided to employees via the RPMGlobal Holdings Limited employee share option plan (ESOP) and an employee share purchase plan. Information relating to these schemes is set out in note 23.

The fair value of options granted under the ESOP is recognised as an employee benefit expense with a corresponding increase in equity. The total amount to be expensed is determined by reference to the fair value of the options granted, which includes any market performance conditions, but excludes the impact of any service and non-market performance vesting conditions. Non-market vesting conditions are included in assumptions about the number of options that are expected to vest. The total expense is recognised over the vesting period, which is the period over which all of the specified vesting conditions are to be satisfied. At the end of each period, the Group revises its estimates of the number of options that are expected to vest based on the non-market vesting conditions. It recognises the impact of the revision to original estimates, if any, in profit or loss, with a corresponding adjustment to equity.

(q) Value Added Taxes (Including Goods and Services Tax)

Revenues, expenses and assets are recognised net of the amount of Value Added Tax (VAT), except where the amount of VAT is not recoverable from the relevant tax authority. In these circumstances the VAT is recognised as part of the cost of acquisition of the asset or as part of the item as expense.

Receivables and payables are stated with the amount of VAT included. The net amount of VAT recoverable from, or payable to, the relevant tax authority is included as a current asset or liability in the consolidated statement of financial position. Cash flows are presented on a gross basis. The VAT components of the cash flows arising from investing and financing activities which are recoverable from, or payable to, the relevant tax authority are classified as operating cash flows.

(r) Contributed Equity

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

1. Summary of Significant Accounting Policies (Continued)

(s) Earnings per Share

i) Basic earnings per share

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company, excluding any costs of servicing equity other than ordinary shares
- by the weighted average number of ordinary shares outstanding during the financial year.

ii) Diluted earnings per share

Dilutive earnings per share adjusts the figures used in determination of basic earnings per share to take into account:

- the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares
- the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.

(t) Financial Guarantee Contracts

Financial guarantee contracts are recognised as a financial liability at the time the guarantee is issued. The liability is initially measured at fair value and subsequently at the higher of the loss allowance and the amount initially recognised less cumulative amortisation, where appropriate.

(u) Rounding of Amounts

The parent entity has applied the relief available to it under ASIC Corporations (Rounding in Financial/Directors Reports) Instrument 2016/191 and accordingly, amounts in the financial statements and directors' report have been rounded off to the nearest \$1,000, or in certain cases, the nearest dollar.

(v) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

(w) Critical Accounting Estimates and Significant Judgments

The preparation of the financial report in conformity with Australian Accounting Standards requires the use of certain critical accounting estimates. It also requires management to exercise judgment in the process of applying the accounting policies. The notes in the financial statements set out areas involving a higher degree of judgment or complexity, or areas where assumptions are significant to the financial report such as:

- impairment of intangible assets, including goodwill (note 11);
- impairment of trade receivables and contract assets (note 21(a));
- recognition of deferred tax assets (note 5); and
- revenue recognition (note 1(f)).

(w) Critical Accounting Estimates and Significant Judgments (Continued)

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including reasonable expectations of future events. Management believes the estimates used in preparation of the financial report are reasonable.

(x) Parent Entity Financial Information

The financial information for the parent entity, RPMGlobal Holdings Limited, disclosed in note 24 has been prepared on the same basis as the consolidated financial statements, except as set out below:

(i) Investments in subsidiaries

Investment in subsidiaries is accounted for at cost in the financial statements of RPMGlobal Holdings Limited.

(y) New Accounting Standards and Interpretations

There were no new or revised accounting standards adopted that had any impact on the Group's accounting policies or required retrospective adjustments.

Early adoption of standards

The Group has not early adopted any standards, interpretations or amendments that have been issued but are not yet effective.

2. Business Combinations

(a) Summary of acquisition

On 30 November 2022, the Group acquired 100% of the issued share capital of Splash Back Solutions Pty Ltd (Splashback), which owns a unique SaaS (Software as a Service) based solution for the capture, storage and management of environmental data.

The provisionally determined purchase consideration for the acquisition consisted of a \$500,000 cash payment, plus \$255,000 deferred cash payment and \$41,000 earnout estimate.

The fair values of the assets and liabilities recognised as at the date of the acquisition were \$15,000 in current assets (including \$4,000 cash and cash equivalents), \$11,000 in current liabilities and \$792,000 in intangibles – software acquired for sales. There was no goodwill recognised.

2. Business Combinations (Continued)

(b) Revenue and profit contribution

The acquired business contributed revenues of \$60,000 for the Group. All employees were transferred to the Group's various business units and this business cost net \$200,000 to the Group in the financial year.

If the acquisition had occurred on 1 July 2022, consolidated pro-forma revenue from customers for the year, and profit for the year ended 30 June 2023, would have been \$97,417,000 and \$3,669,000 respectively. These amounts have been calculated using the subsidiary's results and adjusting them for differences in the accounting policies between the Group and the subsidiary and tax rates applicable to the Group.

The entities have also entered into a tax funding agreement under which the wholly-owned entities fully compensate RPMGlobal Holdings Limited for any current tax payable assumed and are compensated for any current tax receivable and deferred tax assets relating to unused tax losses or unused tax credits that are transferred to RPMGlobal Holdings Limited under the tax consolidated legislation. The funding amounts are determined by reference to the amounts recognised in the wholly-owned entities' financial statements.

(a) Credit Risk

Employee Share Option Plan (ESOP)

The Employee Share Option Plan (ESOP) was approved by the Board of Directors on 5 February 2008, amended on 7 October 2009, 28 October 2011, 29 October 2013, 24 November 2016 and most recently following approval of shareholders at the Company's 2019 Annual General Meeting.

Eligible participants of the ESOP include any person who is employed by, or is a director, officer or executive (or their approved permitted nominee), of the Group and whom the Board or its nominee determines is eligible to participate in the Option Plan. A permitted nominee includes a company controlled by the employee, a trust in which the employee has, or may have entitlements or such other entity as approved by the Board. Options are granted at the discretion of the Board of Directors.

All options under the ESOP are to be offered to eligible employees for no consideration. The offer to the eligible participant must be in writing and specify amongst other things, the number of options for which the eligible employee may apply, the period within which the options may be exercised, any conditions to be satisfied before exercise, the option expiry date and the exercise price of the options, as determined by the Board. The Board can impose any restrictions on the exercise of options as it considers fit.

The rules of the ESOP plan enable the Board to determine the applicable vesting criteria and to set a timetable for vesting of options in the offer document, including vesting in tranches over a defined period. The Board has the discretion on whether or not to set performance hurdles for vesting or to link vesting solely to a defined service period in order to drive key staff retention and reward longevity of service.

The options may be exercised, in part or full, subject to the employee continuing to be employed at the relevant vesting dates, by the participant giving a signed notice to the Company and paying the exercise price in full. The Company will apply for official quotation of any Shares issued on exercise of any options.

The rules of the plan allow the Board to set the exercise price per Option in the offer document.

Subject to the accelerated expiry terms set out in the ESOP plan (explained further below), options will expire five years after the date of grant subject to the option holder remaining employed by the Group. Unexercised options will automatically lapse upon expiry. (b) Significant Restrictions

Cash and short term deposits held in Chile, Brazil, South Africa, China, Indonesia, Mongolia and Russia are subject to local exchange control regulations. These regulations provide restrictions on exporting capital from those countries other than through normal trading transactions or dividends. The carrying amount of cash included within the consolidated financial statements to which these restrictions apply is \$16,190,000 (2022: \$11,009,000).

26. Operating Segments

Operating segments are reported in a manner consistent with the internal reporting provided to the CEO in order to make decisions about resource allocations and to assess performance of the Group. The reports are split into functional divisions: Software Division, Advisory Division.

Software Division provides all of the Group's Software offerings, including support (maintenance), training and implementation services to mining companies. Advisory Division provides consulting and advisory services which cover technical and economic analysis and assessment of mining activities and resources on behalf of mining companies, financial institutions, customers of mining companies (e.g., coal fired electricity generators), lessors and potential lessors of mineral rights to mining companies, government departments and agencies and suppliers to mining companies and projects. GeoGAS division specialising in coal gas laboratory testing was divested in 2022 and removed from the segment report and its prior year comparatives. Segment revenue, expenses and results include transfers between segments. Such transfers are priced on an "arms-length" basis and are eliminated on consolidation.

The Group generates revenue from multiple streams, including: software sales (perpetual and SaaS), maintenance, advisory and consultancy.

The Group continued to increase its software sales from recurring subscription sales. Revenue recognition under AASB 15 Revenue from Contracts with Customers is complex and subject to error, especially where revenue is recognised over time or with multiple performance obligations.

The Group's disclosures about revenue recognition are included in Note 1(f), which detail the accounting policies applied under the requirements of AASB 15 Revenue from Contracts with Customers.

The assessment of the Group's revenue recognition was significant to our audit due to the materiality of revenue to the financial report, and the complex nature of accounting for the appropriate timing of revenue related to the sale of software and related maintenance services under the requirements of AASB 15 Revenue from Contracts with Customers.

The Group has entered into a number of material contracts, requiring the Group to supply software licence and maintenance services, a number of which included comprehensive contractual provisions. The total value of these contracts are considered material to the Group.

How the matter was addressed in our audit

Our audit procedures included, amongst others:

- Assessing the revenue recognition policy for compliance with AASB 15 Revenue from Contracts with Customers.
- Selecting significant software licence contracts, and reconciling the contract from inception to reporting, alongside the revenue recognition under AASB 15. This included a focus on new subscription sales and the recognition of revenue 'over time'.
- Selecting a sample of licence sales, maintenance services and consulting fees recognised as revenue, and agreeing to supporting invoices, signed customer contracts and proof of delivery where available.
- Obtaining and evaluating credit notes issued post year-end, and completing invoice cut-off testing, to ensure an appropriate revenue cut-off was achieved at balance sheet date.
- Analytical review procedures on all significant revenue streams on a disaggregated balance against expected trends and prior year levels.
- Selecting a sample of receipts and maintenance invoices from the clients' income in advance schedule and recalculating appropriate deferred portion of revenue.
- Obtaining management's revenue recognition
 papers on the relevant contracts, assessing revenue
 recognition for compliance with AASB 15 Revenue
 from Contracts with Customers, including
 identifying performance obligations and allocating
 the transaction price. Further, substantive
 procedures verified amounts recognised as revenue.
- Assessing the adequacy of the Group's revenue recognition disclosures within the financial statements.



Carrying value of goodwill - impairment assessment

Key audit matter

The Group's disclosures on Goodwill impairment are included in Note 11, detailing the allocation of Goodwill to the Group's various cash-generating units ('CGUs'), setting out the key assumptions for value-in-use calculations and the impact possible changes in these assumptions would have.

This annual impairment test is significant to our audit given the material balance of Goodwill as at 30 June 2023, and its importance to the financial statements.

The impact of inputs used in management's assessment required significant auditor attention.

How the matter was addressed in our audit

Our audit procedures included, amongst others:

- Obtaining an understanding of the value-in-use models, and critically evaluating management's methodologies and their key assumptions.
- Assessing management's allocation of Goodwill, and assets and liabilities, including corporate assets to the CGU's.
- Evaluating the inputs used in the value-in-use calculations, including growth rates, discount rates and underlying cash flows applied by management.
- Involving our internal specialists to assess the discount rates and terminal growth rates against comparable market information.
- Assessing the disclosures related to the Goodwill and impairment assessment by comparing these disclosures to our understanding of the matter and the applicable accounting standards.

Other information

The directors are responsible for the other information. The other information comprises the information contained in the Group's annual report for the year ended 30 June 2023, but does not include the financial report and our auditor's report thereon.

Our opinion on the financial report does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial report, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.
