## Notice of intention to extend on-market share buy-back (Buy-back)

27 May 2025

RPMGlobal Holdings Limited (ASX: RUL) [RPM®] today announces its intention to extend its current on-market share buy-back program, which was due to expire on 13 June 2025 (Buy-back), as part of its ongoing capital management strategy, for up to an additional 11,000,000 RPM shares (approximately 5% of the company's shares on issue), for a further twelve (12) month period from Friday 13 June 2025 through to Friday 12 June 2026.

RPM has to date, bought back 17,095,128 shares (\$32.22 million, at an average price of \$1.88 per share) through the Buy-back program since it commenced on 14 June 2022.

The Board has approved the extension of the current Buy-back program to allow the company to buy-back up to a further 5% of its shares for a further twelve (12) months (from 13 June 2025 through to 12 June 2026) unless closed earlier at the Board's discretion. RPM has today notified ASIC under section 257F of the Corporations Act 2001 (Cth) of its intention to extend the current Buy-back through to 12 June 2026.

The Board's decision to extend the current Buy-back program is part of RPM's ongoing capital management strategy and takes into account the company's current and historical share price as well as the \$80.5 million in available cash (as at 26 May 2025)). The Board considers the extension of the Buy-back (in these circumstances) a sound use of available capital.

An Appendix 3C in relation to the Buy-back extension will be lodged immediately following this announcement. Veritas Securities Ltd (ASX Market Participant - FinClear Execution Ltd) continues to act as broker for the Buy-back.
